

## **Accreditation Council for CME Publishes Addendum to 2010 Annual Report Data**

ACCME addendum includes long-term continuing medical education trends and overview of national commercial support distribution

The Accreditation Council for Continuing Medical Education (ACCME®) has released an addendum to the 2010 Annual Report Data, "Analysis of Commercial Support Distribution and Long-Term CME Trends."

The addendum builds on the information included in the previously published annual reports, from 1998–2010, to provide long-term analysis of trends. In addition, the addendum includes new data, made possible because of the Program and Activity Reporting System (PARS), a Web-based portal designed to centralize and streamline the collection, management, and analysis of program and activity data from ACCME-accredited CME providers. The structure of PARS enabled the ACCME to present an overview and analysis of commercial support distribution across the national CME enterprise.
