

## **ACCME 2020 Meeting**

### *Call for Proposals Information Sheet*

New for ACCME's 2020 Meeting, there will be several ways for educators to participate actively throughout the conference. One way to participate is to submit a proposal to our "Call for Proposals," which has three unique submission options:

#### **OPTION 1: Share Your CME Story!**

*You have a CME story to share. How are you changing practice and healthcare through accredited CME? What challenges have you overcome? What have you learned? What inspires you and brings meaning to your work as an educator?*

Selected submissions will be shared in the meeting app, and participant engagement with the CME Stories will be encouraged throughout the ACCME 2020 Meeting. Stories that receive the most in-app participant engagement will have the opportunity to present their stories during the meeting.

#### **OPTION 2: Inspire and Teach! Propose a Session**

*Share your expertise and experience as an educational leader. Submit your proposal for an educational session and help to improve the skills and performance of your colleagues.*

Selected presentation proposals will be featured as breakout sessions on Wednesday and Thursday afternoon of the ACCME 2020 Meeting. Additionally, session facilitators (*up to two per session*) will receive a 30% discount on meeting registration.

#### **OPTION 3: CME Effectiveness & Best Practices: Engaging in CME Research**

*Share your scholarship: What makes CME effective or ineffective in catalyzing learner change and healthcare improvement? Help mentor your colleagues as we pursue together critical questions about CME.*

Selected research project submissions will display a poster of their work throughout the ACCME 2020 Meeting and will present a short oral summary of their project during the **Research Exchange**, a special research session that will take place on Thursday afternoon of the ACCME 2020 Meeting. The primary author for each selected poster will receive a 20% discount on registration for the ACCME 2020 Meeting.

### **Rules for Submission**

1. Submissions will be accepted from Monday, July 15 through midnight Central Time on Friday, September 13, 2019.
2. Your submission(s) must be your own/your group's work. All authors/presenters must have had a role in the research, best practice example, or in the planning of the proposed session.
3. For "**Inspire and Teach!**" submissions: should your entry be selected, you agree to attend the ACCME 2020 Meeting in Chicago on May 6-8, 2020 to teach the selected session. A maximum of two facilitators for each selected entry will receive a 30% discount on registration for the ACCME 2020 Meeting. You will be responsible for all travel expenses related to your attendance.

For “**CME Effectiveness & Best Practices**” submissions: should your entry be selected, you agree to attend the ACCME 2020 Meeting in Chicago on May 6-8, 2020 to present your research. The primary author for each selected entry will receive a 20% discount on registration for the ACCME 2020 Meeting. You will be responsible for all travel and other expenses related to your attendance.

For “**Share Your CME Story!**” submissions: should your entry be selected, you agree to attend the ACCME 2020 Meeting in Chicago on May 6-8, 2020. You also agree to allow the ACCME to share your story with other participants and encourage their feedback. You also agree to prepare a brief (4-5 minute) oral presentation of your story; you may have the opportunity to share the story orally during the meeting based on participant engagement via the meeting app.

4. By submitting any entry, you give ACCME permission to publish the content you have shared.
5. All entries will be blindly reviewed and scored by the ACCME 2020 Meeting Steering Committee. Selection notification will occur prior to the opening of registration for the ACCME 2020 Meeting.
